## CAR RENTAL CONTRACTUAL CONDITIONS

### IT IS FORBIDDEN TO SMOKE INSIDE THE RENTED CAR

- 1) The first day of rental begins at the moment of the car delivery until 10 am of the following day. The end of the rental is established by the date and time written on the contract. **Eventual delays, if not reported to management, will be charged at an extra cost equal to one day of rental. Those wishing to extend the rental period must ask authorization to management, at least 4 hours before the end of the contract, and receive confirmation that the car is available.** 24 hours after the end of the contract, should management not be informed, a report for misappropriation will be made to the local Authorities.
- 2) If the lessor decides to interrupt the rental period before the end date established on the contract, the cost for the entire agreed period will have to be paid (**unless other agreements were established at the moment of delivery**).
- 3) Pay attention to the car upholstery. In case it gets **stained by wet clothes or inappropriate use, an additional cost will be charged equal to the amount required for the refurbishing of the upholstery or of damaged parts.**
- 4) **Our cars are delivered with a full tank.** When returning the car it is up to the client to refill the tank. Otherwise, 1 litre of petrol for every 10 km., at the cost of € 2,00 per litre, will be calculated and charged with no distinction on the model of car rented.
- 5) **In case of a car accident or mechanical problems, please call** your hotel RECEPTION giving the exact location of the car and hence allow us to guarantee a prompt assistance. If necessary, Garage Studio Rent will provide another car that will be available at that moment. If you wish to interrupt the car rental, the amount of money for the period not used will be returned.
- 6) **Included in the rental price are: VAT 22%, emergency services, RCA: mandatory public-liability insurance** (including passengers). The lessor who causes an accident of which he/she is responsible, will be charged the increases in cost established by the insurance companies plus the cost of damages made to the rented car.
- 7) **We offer (optional, extra cost) Kasco insurance with limitation of liability.**

- 8) Damages to the internal upholstery and to the tires of the car caused by negligence, are not covered by Kasco insurance.
- 9) **What is the "limitation of liability": it is the maximum amount to be paid by the lessor in case of an accident of which he/she is responsible (damages to the car, to people or things, including crystals, vandalism acts, theft or fire). Category (A) cars: € 400,00; Category (B) cars: € 600,00; Category (C) cars € 800,00**
- 10) Our cars are insured for theft and fire with an uncovered liability to be paid by the lessor of € 2.000,00 for category A - B cars, and of € 3.000,00 for category C cars. In order to be exempt of liability in case of theft, the lessor must be in possession of the keys of the rented car and of the report made to the local Authorities.
- 11) On request, Garmin GPS satellite navigation systems are made available by Garage Stadio Rent at the cost of € 8,00 per day. We warn GPS users that, although regularly updated, information provided may sometimes be incorrect. Garage Stadio Rent is not be held responsible for the satellite navigation system.
- 12) **Our cars must be used only within the Italian national territory. To go abroad, lessors must get authorization by management when filling in the rental contract. (penalty: the expiration of Kasco guarantees).**
- 13) I, the subscribed signer of the contract, authorize GARAGE STADIO RENT A CAR S.R.L to use my credit card, if necessary, to pay for the balance of the car rental, only for eventual damages to the car or for refueling in case of missing petrol.
